**JOHN GARDINER** is a true son of Ireland. He was born and raised in Dublin and graduated from University College Dublin's law school, after which he qualified as a solicitor. While at UCD, he had the privilege of captaining its rugby team and representing Ireland in rugby at the Under 21 level. In 1987, John came to live in New York and joined the global law firm of Skadden Arps Slate Meagher & Flom LLP, where he became a partner in 1995 and now serves as its global head of Litigation and International Arbitration Practice Group.

John is a longtime supporter of cultural organizations, including Irish and Irish-American institutions. He was a trustee of the Massachusetts Museum of Contemporary Art (MASS MoCA) for twelve years and is a member of the North American Advisory Board of UCD. He joined the Board of the Irish Repertory Theatre in 2013. Over his tenure, John has provided essential stewardship, assisting with the capital campaign to renovate the theatre in 2016, and supporting Irish Rep's dynamic response to the global shutdown.
